

## **The Unified Patent Court system is not the best solution for Europe and for innovation**

The undersigned professors and practitioners recall that the Unified Patent Court Agreement (UPCA) suffers some substantial deficiencies and constitutes a significant precedent that challenges the democratic and institutional processes in the EU. There is still time to reflect on the implications of these changes and to review the options for a EU patent system that could provide effective support for European innovation.

The EU democratic process is challenged by the fact that UPCA leaves a major part of the substantive patent law itself in the hands of a non-EU international organization (the European Patent Organization) and of the participating Members States exclusively, without any realistic possibility for the EU legislator (European Parliament and Council) to intervene for amending the substantive patent rules in the future.

Therefore we urge all the decision-makers and persons involved in the process of adjusting the UPCA, following the withdrawal of the United Kingdom, **to pause** and to consider alternatives solutions. We believe that several alternative systems that solve most of the UPCA deficiencies do exist. Those solutions could better benefit the industry and innovation in Europe.

Many European academics and practitioners are ready to further elaborate those alternative solutions<sup>1</sup>.
